RESOLUTION NO. 01 OF 2004

THE APPOINTMENT OF A PANEL OF CONCILIATORS AND ARBITRATORS (2004/2005).

1. Scope

This agreement binds:

- 1.1 the employer;
- 1.2 the employees of the employer who are members of the trade union parties to this agreement; and
- 1.3 the employees of the employer who are not members of any trade union party to this agreement, but who fall within the registered scope of Council.

2. Noting that the:

- 2.1 Labour Relations Act, 1995 (Act No. 66 of 1995) (as amended);
- 2.2 Constitution of the PSCBC; and
- 2.3 Clause 8.1. of the Dispute Resolution Procedure of Council (Resolution 11 of 2002),

make provision for Council to appoint its own panel of Conciliators and Arbitrators at Council's Annual General Meeting;

and that the Council has:

- 2.4 adopted a Code of Conduct for Panellists (Addendum "1" of Resolution 11 of 2002).
- 2.5 developed a standard Contract of Work agreement for the appointment of Panellists.

3. The parties resolve that:

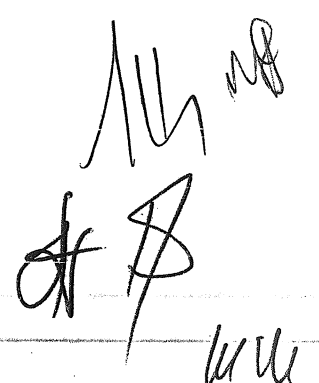
- 3.1 The Council appoints the panellists listed in Annexure "A" in terms of Council's dispute resolution procedure (Resolution 11 of 2002).
- 3.2 The appointment of the panellists is subject to the panellists':
 - 3.2.1 signing the Contract of Work for Panellists;
 - 3.2.2 agreeing to be bound by the Fee Policy for Conciliators and Arbitrators; and
 - 3.2.3 agreeing to be bound by the Code of Conduct for Conciliators and Arbitrators;

4. Dispute Resolution:

- 4.1 Any dispute arising from the provisions of this resolution will be dealt with in terms of Council's dispute resolution procedure.

5. Implementation of Resolution

- 5.1 This agreement comes into effect on the date of signing.
