Objective

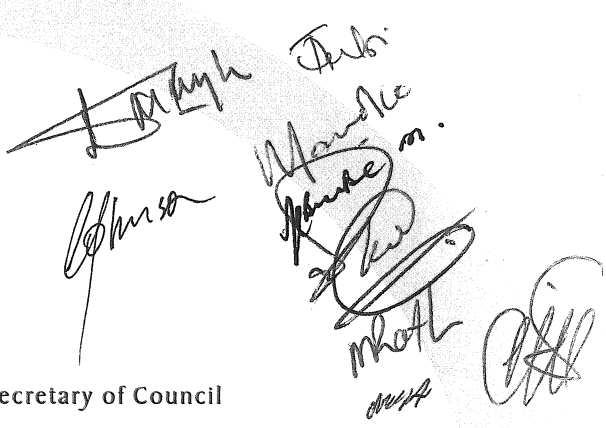
2. The objective of this agreement is to amend Clause 1 of Resolution 1 of 2001.
