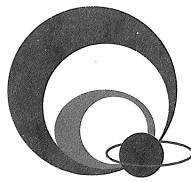

RESOLUTION No. 11 OF 2001.

AMENDMENT TO PSCBC CONSTITUTION : INCLUSION OF DISPUTE RESOLUTION PROCEDURES OF COUNCIL INTO CONSTITUTION

1. Scope

This agreement binds:

- (a) the employer;
- (b) the employees of the employer who are members of the trade union parties to this agreement; and,
- (c) the employees of the employer who are not members of any trade union parties to this agreement, but who fall within the registered scope of Council.

2. Noting that:

- 2.1 Section 30 of the Labour Relations Act No.66 of 1995 ("the LRA") stipulates that the constitution of every bargaining council must provide for the procedure to be followed if a dispute arises between parties to the bargaining council;

- 3.1 The PSCBC Constitution is amended to include the Dispute resolution procedure, as set out in resolution 3 of 1998 to the Constitution as Schedule 1.

4. Dispute Resolution:

- 4.1 Any dispute arising from the provisions of this resolution will be dealt with in terms of PSCBC dispute resolution procedures set out in schedule 1 of the Council constitution.

5. Implementation

- 5.1 This agreement shall come into effect from the date that the last party required for majority support has signed it.

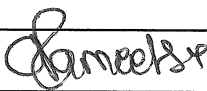
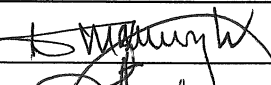
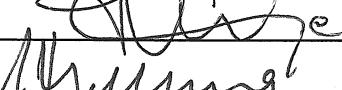
