AMENDMENTS TO THE CONSTITUTION: CLAUSE 18.11- SUBMISSION OF
AUDITOR'S REPORT TO THE REGISTRAR

1. Noting: -

- 1.1. Clause 18.8 of the Council's Constitution that the year-end of Council is 31 March.
- 1.2. Clause 11.3 that the Annual General Meeting of Council is convened during the month of June 1999
- 1.3. Clause 11.4 (d) and (e) that states that the financial statements of Councils and report of the auditor shall be dealt with at the Annual General Meeting,
- 1.4. And that Clause 18.11 is not consistent with the clauses above.

2. The parties to the PSCBC hereby, unanimously agree to the following amendments to the Constitution of the PSCBC: -

Reword the following clauses to read; -

" " denotes insertion
[] denotes deletion"

Clause 18.11:

"Certified copies of the audited statements and the auditor's report shall be transmitted to the Registrar, Department of Labour, within 30 days after the [close of the period covered by the statements] acceptance at the Annual General Meeting of Council."

3. This agreement will come into effect once the amendments are certified by the Registrar in terms of section 57(3) of the Labour Relations Act, 1995.



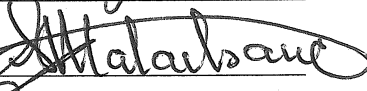
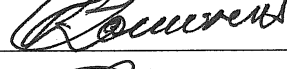
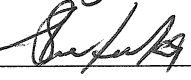

3. This agreement will come into effect once the amendments are certified by the Registrar in terms of section 57(3) of the Labour Relations Act, 1995.

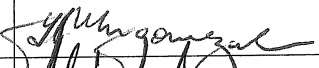
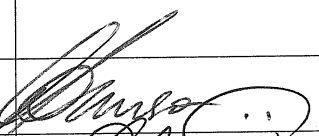
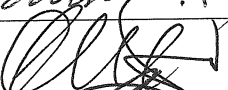
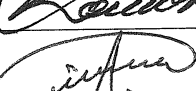
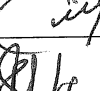
